- 4. Profanity, objectionable language, disorderly acts or illegal activities of any kind are absolutely prohibited, and those violating this prohibition will be ejected from the premises.
- 5. Any damage to municipal facilities shall be promptly repaired at user's expense. NO EXCEPTIONS.
- 6. Organizations/Individuals using the facilities must clean up afterwards.
- 7. Any organization with youth under 18 years old requires the presence of adequate adult supervision at all times.
- 8. The fee is payable before use begins. Make check payable to Village Athens.

Fees:

Residents of the Town and Village of Athens are not required to pay a fee for use of the park.

Non-residents must pay a fee of \$50.00.
